Insolvency proceedings are a powerful tool in identifying and recovering assets. If used properly, a liquidation involves the appoint-

ment of an independent professional over the person or entity to investigate its affairs and identify and recover assets. A liquidator steps into the shoes of the directors of an entity and is entitled to information about the company to which the directors would have been entitled. While liquidators have duties to the court, being independent means that they do not have any bias as to what actions are taken to procure and control assets.

Additional benefits of appointing a liquidator are:

- The costs of the liquidator and thus of identifying and recovering assets is borne by the insolvent person or entity;
- Liquidators have broad and greater powers available to them to seek information and obtain evidence:
- In some jurisdictions liquidators may have both civil and criminal powers; and,
- Liquidators may have remedies not commonly found in litigation.

Since the introduction of the various cross border insolvency provisions and the UNCITRAL Model Law in jurisdictions across the world, KRyS Global has noticed an increased ease with which the appointment of an insolvency practitioner in the offshore centers has been granted recognition in foreign jurisdictions. As an example, Krys, in his capacity as the Official Liquidator of Fairfield Sentry Ltd, the largest feeder fund to the Bernie Madoff investment scheme, obtained cross-border recognition under the provisions of Chapter 15 in the US with respect to insolvency proceedings in the British Virgin Islands. This recognition enables the Liquidator to investigate and identify assets located in the US or commence actions against a party located in the US and ultimately realize recoveries for the benefit of the entity's stakeholders.

Our team has extensive experience in compliance and corporate governance matters. We have been appointed as Controllers, or called upon to assist the regulators in undertaking a review or taking control and monitoring business operations that are having difficulty complying with regulations.
